

## **Terms and Conditions for Subscribers to the National Technical Reports Library**

1. **Scope:** The National Technical Information Service (NTIS), United States (U.S.), Department of Commerce (DOC), compiles the National Technical Reports Library (NTRL) database and allows access through subscriptions. Any person or organization who agrees to these Terms and Conditions by submitting this form to NTIS signed by the person or an authorized signatory of the organization (e.g., corporation, institution, nonprofit organization), is a "Subscriber." NTIS hereby grants Subscriber a non-exclusive, non-transferable license to make the NTRL available to Subscriber's Authorized Users for Authorized Purposes.
2. **Authorized Users:** Authorized Users are persons who are Subscribers or, if Subscriber is an organization, persons who are Subscriber's employees, patrons, students or agents or who are otherwise approved to access the NTRL by Subscriber provided that they agree to use the NTRL only for Authorized Purposes.
3. **Authorized Purposes:** Authorized Purposes are limited to search, retrieval, display and downloading of NTRL data through Subscriber's computer system, including downloading of NTRL data to a computer that is not part of Subscriber's computer system. Sale of the NTRL data and replacing, altering, or otherwise changing any of the data are NOT Authorized Purposes.
4. **Security:** Subscriber understands that any attempt by any person to gain unauthorized access to a U.S. Government Web site through access to the NTRL will result in Subscriber's immediate loss of access and may result in civil or criminal prosecution of the person or persons attempting such access. Subscriber will take appropriate action to ensure that persons gaining access to the NTRL are aware of their potential civil and criminal liability for attempting to gain unauthorized access to U.S. Government Web sites.
5. **Third Party Usage:** Nothing in these Terms and Conditions authorizes Subscriber to sublicense the NTRL to another party, to make it available via a gateway, or to otherwise make it available to anyone who is not an Authorized User of that Subscriber or for any purpose that is not an Authorized Purpose.
6. **Copyright:** Information produced by Federal Agencies of the United States is generally not subject to copyright in the U.S. (17 U.S.C. §105); however, Federal agencies reserve all rights to seek and obtain copyright protection in countries other than the U.S. for information authored by the Federal Agency. Moreover, Federal reports included in the database often contain copyrighted material used with permission of the copyright owners. NTIS makes no representation about the copyright status of any technical reports in its collection, or portions thereof. Authorized Users are responsible for securing appropriate permission.

7. Liability: The U.S. Government/NTIS (a) makes no warranty, express or implied, with respect to information provided under this agreement, including, but not limited to, implied warranties of merchantability and fitness for any particular use; (b) assumes no liability for any direct, indirect or consequential damages flowing from any use of any part of the NTRL; and (c) assumes no liability for any errors or omissions in NTRL data.

8. Indemnification and Hold Harmless: Except where prohibited by law, subscriber shall indemnify and hold harmless NTIS from all claims, liabilities, demands, damages, expenses, and losses arising from or in connection with Subscriber's use of the database. This provision will survive termination of these Terms and Conditions and will include any and all claims or liabilities arising from intellectual property rights. If Subscriber is a Federal Agency of the United States, this clause is not applicable.

9. Governing Law: This Agreement will be governed by applicable Federal law of the United States.

10. Period: This Agreement shall remain in place while the Subscription remains current, up to a maximum period of five years.
